This Memorandum of Agreement (MOA) made and entered into this First day of April Two Thousand Sixteen between **Webel Informatics Ltd. (A Govt. of West Bengal Undertaking)** here in after referred to as WIL, (which expression shall where the Context so admits include its successors and permitted assignees), having its office at 225F, A.J.C. Bose Road, Kolkata - 700020, on the one part,

And

Lady Brabourne College, under the Higher Education Department of the Government of West Bengal and an affiliate of Calcutta University, having its premises at P1/2, Suhrawardy Avenue, Kolkata - 700017 hereinafter referred to as LBC, (which expression where the context so admits include its successors and permitted assignees) of the other part has to state that whereas LBC is desirous of continuing to provide the students of the college with the facility of a Computer Course at its premises, as has been provided since 1996.

and whereas WIL is prepared to continue to offer the aforesaid Computer Course assistance by way of providing necessary support for the said course as mutually agreed in the meeting between WIL & LBC on 4th March, 2016 in continuation of its services provided for the same courses to the College since 1996 in accordance with the agreement between WIL & LBC dated 18.04.1996.

The immediate goal of this collaboration is to develop and run a self-financing course in Computer Course of not more than two years durations at LBC, at the conclusion of which each successful student will be issued a Diploma in Computer Application by WIL.

To fulfill this objective

WIL shall

Frame a course keeping in mind the basic demand in the market as mentioned above. Advanced level modules may be introduced in the third year depending on students demand.

- Teach each level for a duration of two years covering One Hundred & fifty (150) hours of teaching time at the rate of four (4) hours per week under normal circumstances.
- Arrange & conduct class tests and qualifying examination according to a schedule in keeping with the academic calendar of the College.

LBC shall

- Appoint a coordinator from among the members of the Teaching Faculty of the college to liaise with the designated faculty / representatives of WIL regarding matters relating to the smooth running of the said course.
- Motivate all Students to take up the Course irrespective of any stream.
Provide classrooms and audio- visual aids as may be required from time to time.
- Facilitate the holding of Examination.

Both WIL and LBC are in agreement that

- This MOA is renewed for a term of Three (3) years w.e.f the date of execution of this agreement. On completion of the agreement, i.e., 3 years, WIL shall have the option to renew the agreement on mutually agreed terms and conditions. However, in the event of renewal, WIL shall put its option by a 3 months prior notice to LBC before the expiry of the initial term.
- Fees for entire course (2 years) shall be Rs. 2,400.00 for each student payable in two equal installments @ Rs. 1,200.00 per year at present.

- Tuition fees will be collected by WIL/Training Provider and a statement will be placed before LBC at the end of each academic session.
- LBC will get @10% of the total course fees on account of its share, which WIL/Training Provider will pay to LBC at the end of each admission procedure in each session.
- The classes will be set between 9.15 am and 5.30 pm on each working day accommodating them within normal class hours as far as is permitted by the general routine of the College. If necessary classes may be held on Saturdays depending on the requirement of the course. Computer Practice sessions for students may be arranged during the College hours according to student availability.
- Both WIL & LBC shall not be liable for any obligation hereunder to the extent that the Performance of the relative obligation is prevented by the existence of a Force Majeure of any Nature and shall be suspended from the obligation owing to the duration of Force Majeure.
