

LADY BRABOURNE COLLEGE, a premier women's college in Kolkata, affiliated to the University of Calcutta and run by the Government of West Bengal, was founded in July 1939 in a rented house in the Park Circus area. It was named after Lady Brabourne, the wife of the Governor of Bengal till February 1939. The College began with thirty-five Muslim girls and nine faculty members with the objective of promoting higher education among Muslim women. The foundation stone of the building in which the College is presently housed was laid by Sir J. Woodhead, the Governor of Bengal, on 26th August, 1939. The College celebrated its Golden Jubilee in 1989 and Diamond Jubilee in 1999 and has now emerged as a multicultural venue for students from varied backgrounds. In 2006 the College was accredited by the National Assessment and Accreditation Council (NAAC) and awarded an 'A' grade (85-90%) certification. The institution, which has already left an indelible mark in the world of higher education, celebrated its Platinum Jubilee Year in 2014 when it completed 75 glorious years of consistent endeavour towards women's education, empowerment and emancipation. Lady Brabourne College sustained its tradition of brilliance and was awarded an 'A' grade by the National Assessment & Accreditation Council (NAAC) again in 2014.

In 2022 the college was re-accredited with an 'A' grade by NAAC for the third consecutive cycle.

# The present Principal, Professor Siuli Sarkar has been awarded the prestigious "SHIKSHA RATNA" by the Government of West Bengal in 2017.

The College has recently been awarded the prestigious 'Ananda Shiksha Samman' by ABP Ananda. This initiative from ABP Ananda recognises those institutions that have



made a mark for themselves in Eastern India and beyond, the torch bearers of Eastern India's spirit of eminence.

According to the 'India Today' ranking in Top Bachelor of Science (B.Sc.) Colleges in 2024 Lady Brabourne College has been ranked 68 in India, whereas in Arts section it has been ranked as 53 in India. In Top3 Colleges City-Wise 2024 ranking by Zee 24 Ghanta Lady Brabourne College has been ranked first in Kolkata.

Grants and Funds : As a College that has attained high standards in teaching, research and extension activities and thereby holds a promise of excellence, Lady Brabourne has been granted the CPE (College with Potential for Excellence) status by the UGC (University Grants Commission). The College received a sum of Rs. 1 crore in Phase I for improving and strengthening its infrastructure. The University Grants Commission (UGC) has approved the status of "College with Potential for Excellence" (CPE) to Lady Brabourne College for the second phase of five years under the Scheme. In CPE Phase II, the College has been sanctioned a sum of Rs. 1.5 crores. Further, it has also been selected for the prestigious 'Fund for Improvement of Science & Technology' (FIST) granted by the Department of Science & Technology (DST), Govt. of India to colleges of distinction. Among the many colleges that had applied for FIST in the year 2010, Lady Brabourne was selected as one to receive a fund of Rs. 50 lakh for a period of five years to upgrade infrastructure for teaching and research in various fields of Botany, Chemistry, Geography, Mathematics, Microbiology, Physics and Zoology. As a ranked and reputed College, Lady Brabourne was also selected for a special grant, under the DBT-Star College Scheme, from the Department of Bio-Technology, Government of India. After the successful completion of the programme under DBT-Star College Scheme in 2012 in which the College received a grant of Rs. 55 lakhs, the College has again been selected for the DBT-Star College Scheme, 2017 for a period of 3 years (2017-2020) and has been granted Rs. 1 crore 4 lakhs. The College was granted Rs.30 lakhs by the State DBT in 2015, in favour of the Department of Microbiology. The Department of Higher Education, Science, Technology and Bio-Technology, Government of West Bengal, has sanctioned an amount of Rs. 20 lakhs for the Departments of Botany, Chemistry and Zoology under the DBT-BOOST Scheme 2016-17. Furthermore, the College has been granted Rs. 2 crores by RUSA (Rashtriya Uchchatar Shiksha Abhiyan) for infrastructural development. Lady Brabourne College has been selected as a recipient of grants under FIST (Fund for Improvement of Science & Technology Infrastructure) 2019 of the Department of Science and Technology (DST), Govt. of India.

Only 18 colleges out of 253 institutions from all over India, were favourably recommended on the basis of detailed presentation and interaction before the FIST Advisory Board (FISTAB) at Banaras Hindu University on 17<sup>th</sup> and 18<sup>th</sup> September, 2019.

This is the second time that the College has been selected for this prestigious and coveted grant.



The College has also been recognized by the Department of Biotechnology (DBT), Ministry of Science and Technology, Government of India for the prestigious DBT-Boost to University Interdisciplinary Life Science Departments for Education and Research Programme (DBT-BUILDER), 2019 for advanced research and education and upgradation of Post-graduate teaching and training. Departments of Zoology, Botany and Microbiology will be jointly working under this Programme.

Courses : While the founding faculty of the College mostly belonged to the Humanities stream, Science Courses at the Pass level were introduced in July 1958. Presently the College offers Honours Courses in nineteen subjects, six of which are in the Languages, four in the Social Sciences and nine in the Sciences.

Microbiology inaugurated its Honours Course in 2002. The Statistics Department, which began with a General Course in 2000, opened its Honours Course in 2005. In 2007 a General Course in Computer Science was introduced adding to the Elective options for the students of Physics, Mathematics and Statistics Honours, and in 2010, a General Course in Women's Studies was introduced. Apart from this, to help students develop expertise in special skills, the College offers several Add-on Certificate Courses earliest among which are those in Computer Applications and Spanish Language. Since 2011 a Diploma Course in Computer Applications has been introduced. In order to prepare the students for wider career options the College commenced UGC - sponsored Certificate Courses in Public Relations & Advertising and Multimedia & Animation from 2010-11. From being an exclusively undergraduate college until 2002, the Institution began extending into Postgraduate Courses (PG) and Ph.D. programs with the Geography Department launching its PG Course in 2003. The Microbiology and Mathematics Departments followed suit in 2005 and 2006 respectively. The Physics and the English Departments began their PG Courses in 2007 and 2009 respectively. The Department of Bengali launched its PG Course in 2014. Each of these Post Graduate Departments now has an Advanced Research Centre, approved by the University of Calcutta in 2014. Four new PG Courses have been launched in 2016 by the Departments of Botany, Chemistry, Zoology and Political Science. This brings the number of Post Graduate Departments to ten, at this point of time.

Faculty : Consistent with the steady growth and expansion of the College, the faculty strength has increased to 95 full-time teachers. There are a number of Govt. approved State Aided College Teachers (SACT) in the UG Departments and several Guest Teachers in the PG Departments as well.

Research : Apart from giving emphasis on teaching, the College consistently encourages research programmes that will extend the field for the future. This has successfully utilized the core competence of specializing faculty conducting research in the Sciences and the Humanities. Considerable Research funding has been tapped from various national and state agencies for both major and minor projects.



The College strives to impart a holistic education to its pupils.

Career Counselling Cell :

The Lady Brabourne College Career Counseling Cell has been privy to a number of events throughout this academic year. We have hosted successful campus recruitment drives from Newtown GATE academy and Teach for India initiative which have secured placements for our students. We have collaborated with myriad universities like Brainware University, Techno India University and the like to host information sessions for our students, along with guidance sessions from Mindverse initiative to inform our students about education opportunities in UK, USA and Schengen countries. We have collaborated with ISRO, Cognizant and other Government-non-Government organizations for skill upgradation of our students to help with future career opportunities.

The Career Counselling Cell of Lady Brabourne College was established in 2012 in keeping with the recommendations of the UGC XI th Plan, which provides guidance for establishing Career & Counselling Cells in Universities and Colleges. From its inception, the Cell has been committed to adopt a focussed approach towards enabling students to make suitable career choices as they navigate the professional world after higher education. Among the many different organizations which visit this college under the aegis of Career Counselling Cell are Cognizant, TCS, Infosys and a host of other reputed organizations.



- Psychological Counselling Cell
- The Psychological Counselling Cell offers counselling to students, faculty members and office staff of the College. The initiation of the counselling cell was a part of the CPE initiative taken by the College.
- The individual counselling sessions take place every Saturday from 1.00 to 3.00 pm & Monday from 3.00 to 5.00 pm and the counselling is done by Dr. Srimati Biswas. Confidentiality regarding the sessions is strictly maintained.
- National Service Scheme (NSS)

Students may join a unit of the National Service Scheme (NSS) to take part in various activities generating social awareness about environmental issues, female trafficking, drug abuse etc. Students can also volunteer to teach in adult education programmes while a night school run by the Hostel students for street children from the adjoining slum areas



provides scope for teaching and interacting with the marginalized sections of society. Camping programmes are also organized under teacher supervision by the NSS units.

 Sports & Physical Education
Sports and Physical Education comprise an important facet of healthy student life in Lady
Brabourne College. Our students take part in



myriad sports activities throughout the year to facilitate their physical and mental wellbeing.

In academic session 2023-24, we began our activities with a workshop on rhythmic yoga "Healing through Rhythm" conducted by members from Uttaran Yoga Ashram, Maharashtra. Yoga Day and Khel Diwas were celebrated with much aplomb. An intra-college kho-kho tournament was organized on Khel Diwas, for which our college secured certification for sporting veracity from the Ministry of Sports, Government of India.

The Annual Sports forms an integral part of the academic calendar of our college, and from this year onwards, along with track and field events, interdepartment kho-kho and badminton tournaments

have also found their place in the happenings of the 3-day long sporting routine. More than 30 students from Lady Brabourne College participated this year in the Kolkata Marathon arranged by the Kolkata Police and completed the 5Km and 12Km runs. With immense pride we also note that the Kho-Kho team of Lady Brabourne College qualified this year for the South Kolkata District Games and competed in the same.

Alongside the notable events, the regular physical education of college students includes yoga lessons with our qualified yoga instructor. The college also boasts of a free air-conditioned gym facility equipped with a certified gym trainer which we encourage our students to make use of. The college ground has also been equipped with a badminton court, kho-kho court, and basketball court, alongside indoor table-tennis facilities.

Value Education :

A 'Value Education' Seminar is organized annually by the Internal Quality Assurance Cell of the College for the benefit of both teachers and students. Interaction with students is a necessary feature of this seminar which tries to listen to and address students' problems, while delineating the various aspects and importance of moral values in an individual's life.





### Self-Financing Courses

In consonance with the demands of the employment sector the College offers the following 4 Self-financing Courses so that the students might be better equipped with professional training and a Diploma Certificate. The College strongly recommends any one of the four Courses to the students for their future benefit.

The four Self-financing Courses are :

- 1. Diploma Course in Computer Applications
- 2. Spanish Language Training Programme
- 3. Public Relations and Advertising (UGC sponsored)
- 4. Multimedia and Animation (UGC sponsored)
- 5. Audio Theatre Course

The College has been running a Computer Diploma Course in collaboration with West Bengal Industry Development Corporation Ltd. (a Govt. of West Bengal undertaking) for the benefit of the pupils since 1996. The Course has been subjected to regular review to suit their requirements. Separate syllabi for Humanities, Bio-science and Pure Science disciplines have been framed, each to be taught over a period of two years.

A nominal Total Course fee of Rs. 2,800/- per annum is charged per student for the smooth running of this self-financing Course. The DIPLOMA awarded on successful completion of the Course is jointly issued by the Principal of the College and West Bengal Electronics Industry Development Corporation Ltd. (A Govt. of West Bengal undertaking) under the Department of Information & Technology, Govt. of West Bengal. The course duration is 140 hours.

The purpose of running this Course is to give students proper grounding in the versatile use of computers against minimum effort and expense. For Science students the Course is preparatory for portions of their Under-Graduate syllabus that involves computer programming. All students are strongly advised to enroll for this Course so that they may add value to their Degree Course and equip themselves beyond their Bachelor's Degree for any future career option that they may wish to pursue.

The Certificate Course in Spanish Language Training Programme began in November 2007 in collaboration with WTCC School of Trade and Communication, Kolkata, a foreign language training Institute under Development Consultants Private Limited. Since the advent of globalization effective communication has become one of the important keys to succeed in the professional field. The College has thus taken the initiative of creating a facility for learning the Spanish language. This Course aims to create a foundation of understanding, conversation and basic writing skill of Spanish among the trainees. Considering the large number of Spanish language speakers all over the world, a certificate in Spanish language greatly adds to the student's CV.



The immediate goal of this collaboration is to develop and run a Self-financing Course in Spanish within the College campus.

The total course fee is Rs. 4,000/- only. (Rs. 2,000/- for each level) The specially designed Course consists of two Levels, each of 6 months duration and each comprising 50 classes of 60 minutes. Level-A is designed to develop basic knowledge skills along with proficiency in communication. Level H, after completion of Level –A, provides an understanding of literature and culture in Spanish-speaking countries and developing business communication. At the conclusion of the Course each successful student is awarded a Certificate of Proficiency in Spanish, issued jointly by the College and WTCC. A MOU to this effect was signed on 23-11-07.

The College has introduced two UGC-approved Self-financed Career Oriented Diploma Courses in Public Relations and Advertising and Multimedia and Animation. Both these Courses were introduced in 2010 with UGC's approval and seed money. The Courses are run in collaboration with Webel Informatics Ltd. (A Govt. of West Bengal undertaking). Public Relations and Advertising have become major fields of study today and promise to generate huge job opportunities. The Diploma Course in Public Relations and Advertising will enable the students to step in the employment arena with confidence. The same can be said about the Diploma Course in Multimedia and Animations. The Course will not only nurture the latent creativity of the students but will help to channelize it towards meaningful realization through technological applications. The curricula of both these Courses aim at the development of soft skill in students for a successful professional career. The duration for both the Courses is 3years and the total Course Fee, payable in instalments, is Rs. 4500/- only.

Audio Theatre Course:

An Add-on Course was launched during academic session 2023-24 on 'Audio Theatre' for the Undergraduate and Postgraduate students of Lady Brabourne College with Times of Theatre (TOT) School of Drama. Career prospects in audio theatre, anchoring and podcasting are highly popular nowadays and many students have a natural inclination in this direction. In order to nurture their potentials, for further development of their skills and professionals grooming the course was introduced.

The course is a 32hr. one with a total course fee of Rs. 6,500/- (excl. GST). The course includes topics on introduction to audio theatre, script writing, voice modulation, pronunciation, radio announcements, communication skills, audio podcasting and audio drama. Most of the cclasses are held at college with a final 8hr. 'kane kane' a professional voice recording studio. Classes conducted in the studio are more practical based, where recording and editing process are taught. Eminent personalities from the world of audio theatre like Soumitra Basu, Bijoylaskshmi Barman, Saswati Guha Thakurata, RJ Koushik, Suranjan Dasgupta act as Resource Persons for the course. It is an adequate stepping stone for the growth of students in this field. Students are awarded certificate of Completion at the end of the course.



Since 2008 UGC sponsored Remedial Classes are being held in the College fro S.C./S.T. and minority community students. They are urged to take full advantage of these classes to improve their academic performance.

The first includes the Main College Building, the Science buildings and the Cottage amidst lush greenery, gardens, open spaces and a playground. Over the years the infrastructure has developed and expanded to keep up with the demands of new requirements such as laboratories, computer facilities, a Medical Unit, canteens, a Career Counselling Cell and a sky-gazing unit. The Main Building houses a library, which contains almost a lakh of books and journals. The New Science Building is located opposite to the Roma Chaudhuri Memorial Building and is connected to the Main Building on every floor level. The Merged Scheme Building is a self-sufficient, multipurpose, technologically enabled unit that functions not only as an Examination Hall and a Lecture Theatre but also hosts audio-visual presentations and conferences. The new Roma Chaudhuri Memorial Building, named after the most renowned and longest serving Principal of the College, is adequately equipped to provide space for a Library Complex, and the growing demands of both the UG and PG sections.

The Second Campus in which the Hostel and the Superintendent's Quarters are situated also houses the erstwhile Principal's Quarters, which were converted into a Post Graduate Building for the Geography Department in 2005. A New Hostel Building, funded by the UGC in the last phase of the Tenth Plan, has been completed and now accommodates PG and senior UG students.

Recently a 15 Seaters Dormitory was added as a vertical extension in LBC Hostel.

The College and Hostel Campus are under 24 x 7 CCTV surveillance. An environment-friendly campus monitored by a standing Maintenance and Beautification Committee provides students with the ambience necessary at a centre for teaching and learning. From time to time the Principal holds meetings with the PWD (Civil) concerning upgradation of infrastructure. The maintenance of the garden is high on the agenda in this regard. Rare plants are preserved with great care. Every year plants are counted and naming is done with the help of expert taxonomists. Other than this, tree planting ceremonies are part of the regular activities of the college. The college has been made a plastic free zone and students are constantly sensitized.

During the pandemic period all academic and administrative activities such as conducting semester examinations, evaluation of answer scripts & uploading marks on the university portal, organizing UG & PG admissions, etc were being done virtually. Classes of all departments were taken successfully in the online mode through Google Meet, Team Link, Zoom, etc. following a Central Routine. Not only online teaching, but the outreach towards students was implemented with substantive study material which was provided to them by concerned teachers during the prevalent pandemic conditions. Virtual practical classes were also organized by most of the Science departments. All departments, six Advanced Research Centres, Women's Studies Centre and Library



organized regular webinars at the State, National & International levels. Departmental as well as Central Meetings were held in the online mode. The Annual Day celebration and virtual Prize distribution, Annual Sports including yoga display, webinars organized by the Science Promotion Committee in the form of talks by eminent doctors for proper mental health of students during the pandemic period, were all conducted totally online.

Offline classes have resumed from February 2022 as per the directive of the Government of West Bengal, and the campus is once again vibrant with the multifarious activities of students and staff.

### Notable Events of 2022-2023:

Lady Brabourne College was selected as a "hub" college for a UPSC Civil Services Examination Workshop. It was organised on 24<sup>th</sup> June, 2023 by the Higher Education Department, Govt. of W.B. in collaboration with the Career Counselling Cell of the College and Satyendra Nath Tagore Civil Services Study Centre (SNTCSSC) - an initiative launched at the behest of the Hon'ble Chief Minister, Smt. Mamata Banerjee to provide best quality and highly subsidized coaching for UPSC Civil Services Examination. The occasion was graced by dignitaries like Sri Surajit Kar Purkayastha, IPS (retd) former Police Commissioner, Govt. of W.B. and Chairman, SNTCSSC, Sri Manish Jain, IAS, Principal Secretary, Dept. of Higher Education, Govt. of W.B., Smt. Nandini Chakravorty, IAS, Principal Secretary, Dept. of Tourism, Govt. of W.B., Prof. Jayasri Ray Chaudhuri, Director of Public Instruction, Govt. of W.B. and other IAS & IPS officers. The workshop was organized for students aspiring for the civil services.

A Principal's meet was organized by the Career Counselling cell of Lady Brabourne College on 21st March 2023 in collaboration with Presidency University, Bangalore. It was an event for the first time when Principals and IQAC coordinator of various renowned colleges came together with the purpose of sharing their view and vision. The meet aimed to provide the student with a unique opportunity to gain an understanding of professional world and to make an informed choice when choosing their careers.

A team of 15 students from the Political Science Department of the College participated in the district level Youth Parliament Competition 2022-23 organised by the Department of Parliamentary Affairs government of West Bengal held on 16th September 2022 in the Scottish Church College. The Youth parliament team as a whole won the 3rd prize in the Youth Parliament Competition.

Individual prizes were won in the categories of Best Secretary General and first prize in the Extempore speech Competition. Sahana Debnath stood first in the Extempore Competition during the Youth Parliament Competition for Presidency Division held at Krishnanagar Don Bosco School on 20th November, 2022.



### Notable Events - 2023 - 2024 :

The Women's Studies center, Lady Brabourne College holds regular programs related to gender studies and gender activism. Some of the most recent activities are as follows :

A Cancer Awareness Programme held in collaboration with The Bengal Obstetric and Gynaelogical Society and the Rotary Club on 3rd August 2024 was meant for students, staff as well as for community outreach in the nearby areas.

The Center has organised a 7 day international Interdisciplinary Workshop titled "Bridging the Gulf : Gendering Empowerment and Progress", to be held online from 19th September, 2024 to 25th September, 2024. The workshop shall focus on themes of gender empowerment, gender equity and gender justice, among others, and shall include a wide range of perspectives on gender across various disciplines.

The Center also plans to reintroduce self defense training for both students and teachers in 2024 - 2025.

Seminar on Madhusudan Dutta :

A two day state level seminar organised by Bengali, Sanskrit & Philosophy department in collaboration with The Bhawanipur Education Society & funded by Higher Education Department, Govt. of West Bengal was held to commemorate bicentenary of Great Bengali poet Michael Madhusudsn Datta on 9th & 10th July. Scholars from all over West Bengal & eminent Resource persons were present there. A book will be publish soon on Madhusudan.

### INTERNAL QUALITY ASSURANCE CELL (IQAC)

Report of the IQAC:

The IQAC of Lady Brabourne College is compliant with UGC Regulations and functions diligently as a policy framing, quality promotion, and monitoring unit related to academic progress of the Higher Education Institution (HEI). With the Principal as the Chairperson and IQAC Coordinator as the Chief Executive, the body has been functioning with External Academic Experts and Senior Faculty Members to prepare Annual Quality Assurance Reports for NAAC Evaluation and keeping the College updated for gradation by NAAC. In the last completed year 2023-24 the IQAC has organized Faculty Development Programmes such as MOOC Orientation and a Comprehensive Competitive Examination Guidance with RICE Destination Delhi, both in September. It also invited an NGO Agami Nirman to give the students a first-hand exposure of acid attack victims and handling social injustice on October 6th. The IQAC participated in entering into MoUs with academic organizations for motivating academic enrichment beyond syllabi. It also actively worked to initiate an Add on Course in Anchoring, Content Writing, Elocution and Podcasting with ToT drawing encouraging response from enrolled participants which included students and teachers. In 2024 IQAC pursued its long time aim of introducing Enterprise Resource Planning (ERP) solutions and the massive data transfer work into an integrated management system is underway. On 5th January Swami Kamalasthanandaji addressed Faculty on Mental Health and Well Being in a one-day workshop. On 29th February a book-reading session by young prize winning author Tanima Das was organized in collaboration with the Times of India group and the audience response again was very encouraging. The vibrant nature of the IQAC may be understood with reference to the above multipronged activity mentioned here.



### Under Curriculam and Credit Framework, 2022

The Department of Higher Education, Government of West Bengal, has launched the Centralised Admission Portal for admission to UG courses for the session 2024-25. Admission to UG courses offered by Lady Brabourne College will be conducted through the Centralised Admission Portal.

All admission-related information and relevant notifications will be available at the Centralised Admission Portal: https://wbcap.in and on the college website: www.ladybrabourne.com. Lady Brabourne College offers Major in 19 subjects for the semester-wise 4-year B.A. /B.Sc. (Honours with or without Research) courses (under CCF, 2022). A candidate will have to choose any one of the following subjects as Major :

Humanities & Language Discipline (B.A.)	Major Subjects	Bengali, Economics, English, Geography, Hindi, History, Persian, Philosophy, Political Science, Sanskrit, Sociology, Urdu
Science Discipline (B.Sc.)	Major Subjects	Botany, Chemistry, Economics, Geography, Mathematics, Microbiology, Physics, Statistics, Zoology.

There is no provision for admission to B.Com., B.Ed., or Multi Disciplinary (General) Courses. Admission is strictly merit-based.

Students from ISC, CBSE, WBHSC, and other boards, approved by the University of Calcutta, are eligible for admission to this College. Foreign students may also apply through the University of Calcutta.

Minimum Eligibility Criteria for application to all the UG courses offered by the college as well as the Merit Index calculation formulae are given on the Centralised Admission Portal.

Merit List for all courses offered will be published on the Centralised Admission Portal. The College follows government statutes regarding admission of candidates belonging to S.C. and S.T. categories in each course vide Govt. Order No. DRSC/T /165 /2000 / 6(A).As per the West Bengal State Higher Educational Institutions (Reservation in Admission) Act 2013, G.O. No. 746-L, dated 30th April 2013, seats are reserved for persons belonging to Other Backward Classes of Categories A and B. The list for Other Backward Classes-Category A and Other Backward Classes-Category B may be determined and notified by the State Government from time to time.

SC, ST, OBC-A, OBC-B candidates from outside West Bengal will not be considered as Reserved Category. They may apply for admission as unreserved candidates.

As per memorandum No. 339- Edn (CS) /OM -74 L /2023, dt. 26-05-2023, seats are reserved for persons belonging to Economically Weaker Section (EWS).

Candidates seeking admission under reserved categories should produce valid certificates issued by competent authorities during verification of documents.



For Persons with Disabilities (PwD), reservation will be maintained as per the relevant norms (vide G.O. No. 1084 (20) – Edn (U) /EH /1U-89/ 13 dated 07.12.18 of Dept. of Higher Education, Govt. of West Bengal). Candidates seeking admission under PwD category should produce valid certificates issued by the competent authorities during verification of documents.

Admission to the UG courses is subject to merit position of candidates in the coursewise Merit List and available seats in each course and each category. Hostel accommodation is available for eligible candidates.

All online admission is provisional and is subject to verification of relevant documents. The college reserves its rights to cancel a candidate's admission if the documents are not found in conformity with the declaration made in the form submitted online.

It must be noted that if a candidate cancels her admission to a particular course, she cannot claim seat in that course later.

### RAGGING

There is an Anti Ragging Cell in places in Lady Brabourne College. It measures as ragging the environment throughout the campus. Ragging, in any form, is totally prohibited in the College and its Hostels. Any one indulging in such acts shall be subjected to punishment by the concerned authorities and / or a Court of Law. Anti-Ragging Cells of the College and Hostel always keep strong vigil to maintain safety and security of the students. The following are some of the measurers followed for this purpose in the Hostel:-

- 1. Round the clock monitoring through CC TV surveillance is carried out. This practice is in vogue since 2020.
- 2. The Residential Hostel-In-Charge visits the boarders several times at morning and night and stays updated with the students' needs and concerns.
- 3. Boarders are apprised of the Anti-ragging Committee comprising of the Hostel Superintendent, faculty members, student representatives and non teaching staff. The contact numbers of the important members of the Cell are clearly displayed for ready access.
- 4. There is a Grievance box where students can drop their complaints.
- 5. Communication through WApp groups of the Hostel boarders (semester wise) with departmental representatives ensures the security of every single Hostelite.
- 6. Hostelites are assured of psychological support as and when need arises through professional Counsellor.
- 7. Posters with strong Anti-Ragging messages are on display at prominent places.

### WHAT IS RAGGING?

"Ragging" means causing, inducing, compelling and/or forcing a Student, whether by way of a practical joke or otherwise, to do any act which detracts from human dignity, or violate his/her person, or to expose him/her to ridicule, or to forebear from doing any lawful act, by intimidating, wrongfully restraining, wrongfully confining, or injuring him/her, or by using criminal force upon him/her, or by holding out to him/her any threat of such intimidation, wrongful restraint, wrongful confinement, injury, or the use of criminal force.

### SUPREME COURT VERDICT FOR STRINGENT ACTION IN CASE OF RAGGING:

The Honourable Supreme Court of India in its directive to the educational institutions pronounced that all educational institutions should obtain an UNDERTAKING from each candidate at the time of admission to the effect that, he/she is aware of the system of punishment in case of ragging to other students. And that, in case he/she is involved in any case of ragging, he / she is aware of the scale of punishments, including criminal action, cancellation of admission, expulsion from hostel, withdrawal of scholarship, imposition of fine upto Rs. 25,000/-, and / or rigorous imprisonment up to 3 (three) years, etc.

All candidates and their parents / guardians, in their own interest, are advised to make themselves acquainted with the relevant rules, regulations, provisions of law, as well as decisions of various Courts of Law, including those of the Apex Court, in relation to anti-ragging measures in India. IT IS MANDATORY FOR ALL STUDENTS TO SIGN THE FOLLOWING UNDERTAKING WHICH IS TO BE ENDORSED BY THEIR GUARDIANS.

Women's Studies Centre College, which has in various ways been concerned with

Lady Brabourne College, which has in various ways been concerned with the education and empowerment of women since 1939, formally inaugurated its Women's Studies Centre on 8th March, 2010 - the Centenary of International Women's Day.

This UGC approved Centre has, since its inception, been engaged in interdisciplinary academic research and has produced a number of Research Projects undertaken by the teachers of the College.

Moreover, it has a significant number of publications to its credit in its journey of thirteen years. Besides annually publishing its academic journal, *Newsletter* (ISSN: 23954299) that has contributors ranging from veterans in the field to junior research scholars, the Centre has also published four Bengali and four English anthologies. One more English anthology *Gendered Trajectories : Discourses of Difference Resistance & Empowerment* is forthcoming.

The Centre regularly organises Seminars/Workshops, Talks, Gender Sensitization Programmes and Awareness Programmes for students and teachers. National and International Webinars and an Awareness Program have been organized during the pandemic which has seen enthusiastic teacher and student participation not only from other parts of India but abroad as well.

An ICSSR-ERC sponsored 7-Day Online International Interdisciplinary Workshop on Gender Sensitization "Her Story: Past, Present and Future" was organized in collaboration with the NGO Swayam, from 9 th September to 15 th September, 2022 for college and university teachers. The Workshop was attended by over sixty teachers from various parts of the country. In 2024, another 7-day online International Workshop "Bridging Divides : Gender Power & Social Transformation" is being organised in September.

A mural depicting a 'Gender Equal World' painted on the outside walls of the College, was inaugurated on 25 th November, 2022 - the International Day for the Elimination of Violence against Women – an endeavour in which both students of Lady Brabourne College and Swayam's team of artists participated. An Inter - College Debate Competition on "Women Reservation Bill 2023 - can truly benefit Indian Women" was organised in December 2023 in which 9 colleges from various parts of the city participated.

Further, a General Course on Women's Studies for UG students was introduced from the 2010-11 academic session, after obtaining due approval from competent authorities and has been running successfully ever since.





### Post Graduate Courses Offered

The Department possesses sufficient number of GPS handsets for training the students.

Advanced Research Centre for Applied Biochemistry and Microbiology:

Calcutta University approved the Advanced Research Centre for the Post-Graduate department of Microbiology with other 5 PG Departments of the College. The Centre promotes scientific temper and encourages collaborative intra and inter-college research work. The Centre has organized series of lectures, Symposia, Faculty Improvement Programmes and Workshops for students, Research Scholars and teachers of this College as well as other colleges, throughout the year.









A 5 year interdisciplinary project awarded by DBT BUILDER to the department of Microbiology in 2022. As a result several instrument have been procured for advanced research. Several instruments have been procured from the DBT BUILDER grant awarded for funding an Interdisciplinary Project with Microbiology as one of the beneficiaries.

Research Activities : The Faculty members are actively involved in Environmental, Industrial and Medical Microbiological Research in the Department.

A one-year Post Graduate Vocational Course on "Food & Drug Safety" sponsored by the University Grants Commission (UGC) has been launched in 2010 – 2011. The duration of the Course period is from September to August every year. The minimum eligibility criterion for admission to this Course is B.Sc. in any field in Biological Science (Honours).

The Course has been sponsored by the University Grants Commission and the Diploma will be conferred by the University of Calcutta.

as well as reputed teachers of different Universities and different Research Institutes.

Calcutta University approved an Advanced Research Centre in favour of Post-Graduate Bengali Department along with other 5 PG Departments of our college. This Centre hopes to broaden its area of activity by entering into various collaborative projects and research work. The Centre has organized series of lectures throughout the year. Two of them are Sri Jatish Ch. Datta endowment lecture & Sri Pran Krishna Bhattacharjee endowment lecture.

The Centre has digitalized version of rare Bengali *samayikpatrika* such as *Shanibarer Chithi, Dasi* and *Bangadarshan*. The Centre has published a peer-reviewed ISSN journal in 2017, 2018 and 2019.

This journal will be published every year funded by the Higher Education Department, Govt. of West Bengal. In 2022 a book published from this centre titled "Mukto Karo Bhoy". It is a collection of invited lecturers in the workshop held in 2019.





## Students' Council

As per government instruction, the College has a Students' Council. Executive Committee of this body is formed through election of interested students who have to file their nominations. In the absence of any political interference the elections take place in a healthy and democratic manner under the supervision of a committee of teachers led by the Chief Election Officer, appointed by the Principal. The members of the Students' Council are involved in various activities throughout the year including the organization of the Orientation Programme for the First Year students, Fresher's Welcome, Independence Day celebration, Reunion, Kaleidoscope, Annual Sports, Farewell of third year students, etc. as well as maintaining the cleanliness and general environment of the College campus throughout the year.

# Internal Complaints Committee

The Internal Complaints Committee of Lady Brabourne College, (ICC

LBC) was reconstituted in April, 2019 as per the Guidelines laid down by the Ministry of Human Resources Development (University Grants Commission Notification dated the 2nd May 2016 and published in the *Gazette of India*) as mandated for implementation.

• Lady Brabourne College is committed to strictly ensure a zero tolerance policy towards sexual harassment. The College has implemented the UGC guidelines for



the constitution of its ICC in April 2019 as stated below :

- This reconstituted ICC was formed at a meeting in April, 2019 in the presence of the Chief Executive Officer of the MHI, in this case the Principal, Prof. Siuli Sarkar, with teaching and non-teaching following members.
- The ICC LBC has put up big boards at several prominent locations in the College and Hostel premises giving details of the above members so that students may contact them.
- The ICC LBC has also put up on its website information about its presence.
- Procedure of the ICC LBC in compliance with MHRD /UGC guidelines
- When a complaint is received the ICC LBC shall conduct preliminary enquiry, to ascertain the nature of the complaint, documentary or other evidence and recording statements of the complainant and possible witnesses.
- ICC LBC shall then submit the preliminary enquiry report to authority along with record of the enquiry proceedings and any supporting documents.



- In case, the allegations turn out to be of non- sexual harassment, ICC LBC shall refer such complaints to the Grievance Redressal Cell or to the Principal.
- ICC LBC shall comply with the procedure prescribed in the aforementioned UGC Regulation 2015 and the Sexual Harassment Act for inquiring into the complaint in a time bound manner.
- After verification of the Complaint, the ICC LBC shall in consultation with its Chief Executive Officer, in this case, the Principal, Lady Brabourne College, and in keeping with the MHRD-UGC guidelines take punitive action against the harasser.
- If ICC LBC concludes that the allegation made was false, the complainant shall be liable to be punished as per the relevant provision of the aforementioned UGC regulation 2015.
- Dos and Don'ts
- Do not feel hesitation or shame in coming forward to complain.
- Forcefully and assertively tell the harasser that his / her behavior is unwarranted and illegal.
- Keep a detailed record of all incidents related to the sexual harassment. If you feel the need to register a formal complaint later, this record will be helpful.
- How to register complaints
- All complaints must be brought by the complainant in person to ICC.
- Lodge a complaint through email or by a telephone call to any of the members of ICC.
- Enquiry Process
- The enquiry shall be completed within a period of 90 days from the date of the complaint.
- On completion of the enquiry, the ICC shall provide a report of its findings to the employer within a period of ten days from the date of completion of the inquiry and such report be made available to the concerned parties.
- If the allegations against the respondent have been proved, it shall recommend punitive actions to be taken against the respondent to the employer.
- The employer shall act upon the recommendation within sixty days of receiving it.
- Covid -19 related Special Grievance Cell:
- The Cell, constituted as per the Govt. of West Bengal Advisory regarding UG and PG Examinations in view of the Covid -19 pandemic, deals with academic and exam related grievances of the students due to the current pandemic. Students may send their pandemic related grievances to the following mail address: lbc.grievanceredressal@gmail.com
- In case of problems with internet, students may contact the Cell through their respective Head of Department.
- Students' Grievance Cell:

The College has a Grievance Cell where the students can lodge any grievance they may have. The College authorities attempt to address their issues as far as practicable.



College Grievance Redressal Cell:

In keeping with the guidelines issued by UGC, the College has a Grievance Redressal Cell for addressing student grievance related issues, prevention of sexual harassment, ragging and any other area of discontent among students. Grievances from students are collected from a drop-box dedicated for this purpose and housed in the Main Library of the College.

As stipulated by the UGC, all complaints are first addressed to the College Grievance Redressal Cell.

# Principal, Professor Siuli Sarkar-Chairperson

Two Senior Faculty Members are nominated by the Principal functioning as Convenors of the College Grievance Redressal Cell. A few senior teachers are also selected by the Principal as members in the College Grievance Redressal Cell. During any meeting, all members of the Grievance Redressal Cell in consultation with the Principal analyse, address and attempt to resolve cases of grievance registered by students as far as practicable. The CGRC follows the principle of natural justice while considering the grievance of the students.

The Grievance Redressal Cell functions as the institutional mechanism for addressing & effectively resolving student grievances, thereby ensuring transparency & timely redressal of the same.

College Uniform

Each student is advised to acquire a set of the College Uniform which is required to be worn compulsorily on special occasions (as per prior notification by college authorities). The uniform consists of a white sari with red border and a red blouse with sleeves.

Dress Code

While in college students should dress in a manner that is befitting an academic institution. Under no circumstances should their attire cross the borders of decency.

Activities

Students of the College participate in various curricular and co-curricular activities throughout each session. Commendable performance in such Intra and Inter College events are invariably recognized and rewarded.

- Seminars/Webinars are arranged regularly by all the Departments where reputed speakers deliver lectures and interact with the student participants.
- National seminars are organized at the College with the financial support of the UGC and other recognized funding agencies or corporate bodies.



- Teachers / Students are motivated to participate in seminars, workshops held outside the College premises also.
- National Science Day (28th Feb) is celebrated each year mainly by Science Departments through the hosting of seminars, exhibitions, poster competitions and so on.
- The 4" retracting type telescope, a precious possession of the Physics Department, is often utilized to view interesting terrestrial events like nearest vision of Mars, transit of Venus, Sun spots etc.
- Extra Curricular
- Music and Drawing Competitions are organized each year to identify budding talent among students.
- Two-day long Prize distribution and Reunion functions are major cultural events of the College. Active participation of students, alumnae, faculty and non-teaching staff make the programme a grand success.
- Annual College Fest 'Kaleidoscope' is an exciting programme organized by the students and for the students. The event proves to be a big attraction for students not only of Lady Brabourne College but also of other premier colleges of Kolkata.
- The College Magazine, published annually is multi-lingual in nature. Both teachers and students contribute articles on a wide range of interesting topics.
- The Committee in Charge of the Medical Unit & First Aid organizes Health Awareness Programmes annually.

Community Service During Corona Pandemic:

In view of the growing demand for hand sanitizers during the Covid-19 pandemic, the Advanced Research Centre of the Postgraduate Department of Microbiology took the initiative of preparing alcohol-based hand sanitizers in their laboratories following WHO Guidelines. It has been named 'Antimicrobial Handrub'. On 20<sup>th</sup> March, 2020, these were distributed among the first line of target beneficiaries, namely, office staff of the College using public transport, police officials of the local Beniapukur Police Station, and SSKM Hospital, Kolkata.

Sports

The College hosts the Annual Sports before the Christmas holidays. Participation of students, teachers and staff makes the winter afternoon really enjoyable. Students

also participate in the Inter-College Sports Meet organized by Government colleges annually at the S.A.I. Complex, Salt Lake.





# Code of Conduct

- Students admitted to the College are expected to abide by the rules and regulations laid down by the College. (See 'Rules and Guidelines' mentioned in next section)
- Regular attendance in keeping with the stipulations of Calcutta University (See 'Examinations') must be maintained.
- Notice Boards are to be scanned regularly for information on fees payment, registration and form fill-up dates and any other information related to campus activities.
- Ragging in any form is a punishable offence. It is strictly prohibited in the Hostel as well as in the College premises. The College will strictly follow the UGC regulations on curbing the menace of ragging in Higher Education Institutions, [under Section 26(1) (g) of UGC Act, 1956; Order No. F.1-16/2007 (CPPthII), dated 17 June, 2009]. These will be followed to prohibit, prevent and eliminate the scourge of ragging including any conduct by any student or students whether by words spoken or written or by an act, which has the effect of teasing, treating or handling with rudeness a fresher or any other student, or indulging in rowdy or indisciplined activities by any student or students, which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in any fresher or any other student, or asking any student to do any act, which such student will not in ordinary course do and, which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student, with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student.
- Use of 'Mobile Phones' is strictly prohibited in classrooms and corridors during College hours.
- Fees will not be accepted except on the dates notified and must be cleared failing which names may be struck off the rolls.
- Continuous absence for one month without any valid explanation forwarded to the Principal and the Department will also result in name being struck off the Rolls in which case the College will not issue transfer certificates.
- Applications to the Principal's office for issuance of certificates, particulars and concessions, required from time to time by students, are to be submitted well in advance. It may not be possible to issue such documents on the same day.
- Identity cards issued to students are to be displayed on their persons while in the College campus for reasons of security.
- Serious offences or acts of indiscipline may invite expulsion from the College (see next section).



- Disciplinary Committee of the College
- The Disciplinary Committee is a standing body of the College convened to resolve issues of malpractice and misconduct in the campus.
- The Committee consists of the Chairperson and Faculty Members acting as Joint Conveners, six Faculty Members acting as ordinary members, and two Faculty Members of the Department / Departments concerned. With the exception of the Chairperson, who is the Principal, the Conveners and other members are nominated / elected by the Teachers' Council of the College in an open meeting.
- The Committee aims at the maintenance of discipline and the preservation of the dignity of the College campus, to render the environment congenial to promote the pursuit of learning and free exchange of thought. In order to fulfill its objective the Committee has formulated the following guidelines.
- Rules and Guidelines of the Committee regarding
  - A) Malpractice and misconduct of an academic nature such as
  - i) Resorting to any kind of unfair / irregular means during any examination.
  - ii) Violation of the prohibition on use of mobile phones in examination halls and in class rooms.
  - iii) Mutilation of library books
  - B) Non-Academic / Behavioral offences such as
  - i) Ragging in the College and Hostel.
  - ii) Forging signature and presenting fake documents.
  - iii) Destroying any property of the College due to careless and callous handling.
  - iv) Indiscriminate use of mobile / camera phones or any other means harmful to social harmony.

Offenders who are reported against any of the above will be show caused and brought before the Committee.

- The Disciplinary Committee, chaired by the Principal, has the sole discretionary power in arbitrating the cases.
- Punishment may vary from repetition of a year to expulsion (in case of examination related offences) in keeping with the degree of the offence.
- Punishment for offences listed under A and B (iii) & (iv) includes imposition of appropriate fines, demand for replacement of destroyed equipment and confiscation of the offending gadget.
- C) Reports relating to irregularity of attendance are carefully examined before the offenders are show caused by the Committee.
- Medical Certificate must be produced in case of illness.
- Attendance : As per Calcutta University norms.



## INFRASTRUCTURE

## The Library

- Lady Braboume College library was started in the year 1939 with 700 books. The library has three wings 'Main library', 'Library Annexe' and 'Electronic Library'. The library with a collection of books, journals, cartographic materials, old and rare documents, electronic materials, various printed documents, digital collections provides the lifeline for the academic pursuit of students and teachers.
- 'Main library' and 'Library annexe' are housed in the first floor of the Main Building with a spacious reading room extensively used by the teachers and students. Under special circumstances, ex-students are also permitted to utilize its resources. In addition to this, each department has a Seminar Library. All sections of the library runs under 'wi-fi' environment and 'CCTV' surveillance.
- ✤ Lady Braboume College Library is fully automated with open source software 'KOHA' (version: 22.05.04.000) and 'D-Space'.
- ✤ Working hours : The library remains open from 10 am to 5:30 pm from Monday to Friday and 10 am to 3:30 pm on Saturday.

## FACILITIES

- Computer Facility
- The College has a Central Computer Centre where internet browsing facilities are available supplementing the same in the library.
- The Mathematics, Physics, Geography, Microbiology and Statistics Departments have set up their own computer laboratories as computer programming and use of specialized software have become an essential part of the requirements of the syllabi in these subjects.
- In each Department the faculty is provided with computers and on-line facilities over a LAN.
- Reprographic Centres
- The College has 3 Reprographic Centres where teachers and students can photocopy books / journals / documents.
- Power Back-up
- The College has its own generator in order to ensure uninterrupted power supply during classes / examinations / seminars / extra-curricular activities.
- College Auditorium
- The College possesses an auditorium with a capacity to seat approximately 350 people with provision for state-of-art audio-visual facilities which enable the hosting of seminars, conferences, workshops and cultural programmes.
- College Canteen
- Lady Brabourne College has four canteens. Two canteens are situated on the ground floor of the main building near the auditorium. There is a fully air-conditioned 'Food Court' area adjacent to these canteens to serve the student community. The third one is situated on the ground floor of' 'Roma Chaudhuri Building' with air-conditioned sitting area. The fourth canteen 'New Food Villa' is situated in the Hostel campus.



All canteens serve the LBC community from 10 am to 5 p.m. everyday. They serve a variety of food items daily, using good quality ingredients and maintaining hygiene



and cleanliness. The functioning of the canteens is monitored by Convenors of the Canteen Committee. Junk food is not allowed to be served in

♦ Medical Unit

the college canteens.

Lady Brabourne College runs a Medical unit to promote healthy and fit lifestyle of the campus community and focuses on both physical and psychological well-being. The College has a small medical room with observatory bed and First-aid Box with medicines, adjacent to Student's Common Room. The Medical Unit serves one of the most indispensable necessities in the College campus, served by

one doctor and one Group-D staff of the College. There is also provision for round the clock medical emergency services. In case of any serious illness, patients are referred to National Medical College, Kolkata, situated nearby.





- Butterfly Garden
- Conservation of butterflies creates a healthy ecosystem. In order to create awareness about nature conservation among people, a butterfly garden has been set up on an approximately two and a half cottah plot in the Hostel campus of the College. This is a Major Research Project sanctioned by the



UGC to Dr. Anuradha Chaudhuri, retired faculty of the Department of Zoology.

- Rain Water Harvesting
- Lady Brabourne College not only provides a clean and green environment to the students but also tries to sensitize them towards the need for a pollution free environment. With assistance from the State Water Investigation Directorate, the Department of Botany has undertaken a roof-top rain water harvesting scheme for artificial recharge to ground water in the College campus. Rainwater harvesting and artificial recharge is the most suitable alternative to combat water scarcity issues in a highly populated metropolitan city like Kolkata. The main objective of this project is to increase the ground water reserve and reduce arsenic and salinity in the ground water through dilution. A sum of Rs. 43, 24,162/-has been sanctioned by the Department of Water Resources Investigation and Development, Govt. of West Bengal.



- Medicinal Plant Garden
- The College boasts of a medicinal plant garden in its campus. Situated in front of the Department of Physics and New Science Building this garden is regularly maintained and upgraded by the Department of Botany. There are nearly seventy plants of immense medicinal importance.
- Green Campus
- The Green Campus initiative, made by Lady Brabourne College is to develop a healthy and

pollution free environment for young learners. A well maintained Garden premise of the campus, endowed with rare, endemic and exotic plants besides a number of flowering and fruit trees makes the campus eco friendly, and aesthetically pleasing. Besides, a Medicinal Plant Garden, and Butterfly Garden provide natural relief,

amidst this harsh urban setup. The belt of large trees also reduces sound pollution significantly. Several strategies have been adopted by the College to set up a Green Campus and the College has also been certified by the authorized Green Auditors.

Conservation and sustainable use of water is effectively done, by ensuring that a drop is not wasted through

leakage in the pipelines or in the overhead tanks. The Rain Water Harvesting Facility installed in the campus allows recharging of the ground waterwhile recycling of

condensate collected from several air conditioners are used for watering of plants in the garden. Conservation of energy is done by practicing switch off drill by students, and staff while replacement of normal lighting system by energy saving LED tubes and bulbs, have lowered the overall energy consumption significantly. Besides, the installation of Solar Voltaic



units in the campus have allowed us to harness renewable energy sources. The campus maintains its cleanliness with utmost care and waste generated are sorted into







segregated coloured bins as mandated by the Government of India. The carbon neutrality, of the campus is done by plantation programmes during celebration of Van Mahotsab, Spring festival or Annual Function of the College. Workshops, awareness programmes, interdisciplinary seminars and intracollege outreach programmes keep our students well informed about environment related issues. Besides Celebration of World Environment Day, World Wetland Day, allow our students to voluntarily participate in conservation related programmes. Campus Biodiversity Register is maintained by teachers and students to document and record the campus flora and fauna. Other practices for ensuring safe learning environment include installation of Fire Safety Apparatus, Ramp and Toilet for Disabled and installation of Aquagaurd for safe drinking water.

The campus is a Plastic Free Zone and we have taken initiatives to spread the idea of REFUSE, REDUCE, REUSE, RE-PURPOSE and RECYCLE to save our environment from the danger of global climate change.

- Solar Energy Conservation
- In order to meet, albeit to some extent, the ever increasing demand for electricity, Lady Brabourne College has taken up a project that marks a humble beginning in utilizing nature's gift of solar energy. The project is in collaboration with West Bengal Renewable Energy Development Agency, Govt. of West Bengal. Under this project the College has set up solar panels of 1KWp energy on the roof tops of the buildings in the main campus. The solar energy thus produced can be used to run the various electrical and electronics laboratories and can also be used for outdoor lighting of the campus. Very soon we hope to install a solar panel on the roof top of the Hostel as well. The panel at the Hostel can be used to generate electricity for running solar water heater

which will help the students, especially, during the winter months.

- Drivers' Cabin
- Humanitarian and compassionate considerations have led to the construction of a Drivers' Cabin in order to provide a resting place for drivers who have to be present in the College premises for long hours on duty.






- ✤ The Hostel
- The College Hostel with accommodation for 250+ students is located in the adjacent premises, the second campus of the College. Admission to the College Hostel is mainly on the basis of performance in the last examination and the distance of the applicant's hometown. It is ensured that each department has a fair quota of seats in the Hostel.
- Hostel Staff

 The Principal of the College is the ex-officioin-charge of the College Hostel. The running of the Hostel is supervised by the Superintendent and the Hostel Committee comprising College teachers. There is one Assistant Superintendent. Matrons and Maintenance Staff assist them in the day-to-day running of the Hostel.







Besides the usual guards on duty at the Hostel, additional armed security guards have been deployed for ensuring the safety and security of students. Moreover, the College is in the process of installing has installed CCTV cameras in order to enhance vigil and for round-the-clock surveillance.







# RULES

- ▶ In all matters of discipline and conduct, the Hostel is governed by the rules laid down by the Education Department, Government of West Bengal.
- **Ragging in any form is completely prohibited in the College & its Hostels.**
- Students must maintain a decent dress code during their stay in the College Hostel. Under no circumstances should their attires violate the borders of decency.
- ► At the time of admission to the Hostel, each student must be accompanied by her local guardian failing which, admission to the Hostel is liable to be cancelled. Since February 2011 mess system has been introduced. It is mandatory for all boarders to take charge of the mess for fifteen days once a year. After successful completion as Mess-in-Charge the student will receive a certificate from the Hostel Super which is to be produced at the time they fill in their forms for the ensuing University Examinations.

The Boarders of the Hostel are to abide by certain rules framed by the College Authorities, which are as follows:

- > The Hostel facility is provided to unmarried students only and a student getting married after admission has to give up her boarder-ship.
- ➤ Use of any electrical gadget, particularly gadgets like iron / immersion rod / hair-straightener, is strictly prohibited in the Hostel campus. Violation of this rule will lead to a fine of Rs.2,000/-.
- > Absent or unsuccessful candidates in the College Test or University Examinations are not permitted to continue in the Hostel.
- ▶ The Hostel usually remains closed during the Puja Vacation and Christmas Holidays.
- Since the University Examinations are generally held during the Summer Vacation, extension of the Hostel facilities to the boarders will be at the discretion of the College Authorities.
- ➤ After completion of the UG/PG Courses a student's boarder-ship automatically terminates. Withdrawal of boarder-ship before completion of Course has to be intimated to the Superintendent who will release the boarder on receiving all necessary clearances.
- > Before leaving the Hostel boarders are to clear all dues, which are verified by the Fees section.
- Solution >>> At the time of release before Summer Vacation, Puja Vacation and Christmas Holidays boarders have to submit copies of receipts of dues for the term of stay completed.



# Visitors

- > Three categories of visitors are allowed to visit the boarders:
  - 1) Guardian, 2) Local Guardian, must be residing in Kolkata
  - 3) Visitors introduced and approved by both the Guardian and Local Guardian.

# Outing Rule

- Boarders will be allowed night outing only on weekends (i.e. for Saturday and Sunday). Only in case of medical emergency night outing will be permitted other than weekends.
- ➤ Rules and times when boarders are allowed to go out are as follows:
  - a) Monday to Saturday: 7 a.m. to 10 a.m.
  - b) Tuesday and Thursday: 5p.m. to 8 p.m. (for shopping)
  - c) Sunday: 8 a.m. to 5 p.m.

On holidays, no day outing will be permitted.

- Soluting hours must be strictly adhered to, failing which the student will have to appear before the Disciplinary Committee of the College. Punitive measures may lead to cancellation of the Hostel seat.
- > Day scholars can visit their friends in the visiting hours mentioned above for which the day scholars have to show their College Identity Cards.
- Solution Construction Construct
- Sources are not allowed to receive visitors in the College or in the College compound without special permission of the Principal. Visitors are received in the Visitor's Room at the Hostel only during the specified visiting hours.
- A boarder wishing to go out at the stipulated time as mentioned above must personally sign the Gate Book furnishing details of the contact number of her place of visit. The date and the expected time of her return must also be mentioned. Violation of this rule will attract stern punishment by the Authority, which may also include cancellation of Hostel seat.
- Any violation of the above rules are meted with outright cancellation of boardership of the student.



# Boarders

- Strict conformity to the rules of the College and Hostel is required of each student. Punctuality and regularity in classes, silence during study hours and nights must be maintained. Appearance in Class Tests is compulsory.
- >> Boarders must observe the Hostel time schedule given below :

- 🛰 Lunch: 9.30 a.m. to 10.00 a.m. (Sunday 11.30 a.m.)
- 🔉 Tiffin : 4.30 p.m.
- > Dinner: 8.00 p.m. (on feast days 8.30 p.m.)
- Study Hours: 7.00 a.m. to 9.00 a.m.; 5.30 p.m. to 8.00 p.m.; 9.00 p.m. to 11.00 p.m.
- 🔉 Lights off : 11.00 p.m.
- ▶ Hostel Gate closes : 8.00 p.m.
- Sommon Room closes : 10.30 p.m.
- Sources must be punctual at all meals. Late meals will not be served except with special permission of the Hostel Superintendent.
- ➤ Absence from meals at the scheduled hours must be previously intimated to the Matrons.
- The students will have to take their meals on time. If a student skips a meal without prior information to the concerned authority, she will have to pay a fine of Rs. 50/-.
- Except in case of illness, meals are not served in the students' rooms. Any complaints regarding food must be brought to the notice of the Head Matron by the Dining Room Prefect.
- >> Breakage entails a fine according to the cost of the item broken.
- > Tuesdays and Thursdays are fixed for marketing. The Register at the gate must be signed to show the time of departure and return.
- Source and the second s
- Sources and the Hostel Superintendent. They are responsible for the orderliness and tidiness of their rooms and of the Hostel in general.
- Source Boarders must attend their College classes regularly otherwise their Hostel seats may be cancelled.

Rules for Leave of Absence :

Solutions are not permitted to leave or be absent from the Hostel during sessions. However, on medical grounds or in cases of other emergencies, the duration of absence must not exceed one month. Leave of absence will be granted only on production of a medical certificate or a letter from the guardian stating the emergency necessitating the leave as the case may be.



- A boarder absenting herself for more than a week without the permission of the Superintendent is liable to have her name struck off the Hostel rolls. Such boarders returning to the Hostel might be allowed to stay at the discretion of the Principal. They must submit a written explanation to the Principal through the Superintendent stating the cause of their absence.
  - Sources and the second second
  - Regular boarders should join the Hostel after leave by 2.30 p.m. on weekdays and 7.30 p.m. on holidays.

Note : The Hostel provides transport facilities to examination venues during University Examinations.

Medical Facilities & Norms:

- > The College Hostel provides a healthy, hygienic and eco-friendly ambience to the students.
- Students can avail the facilities of a modern gymnasium in the Hostel premises to keep them healthy and fit.
- > There are regular inspections by the KMC for prevention of diseases like malaria, dengue, etc.
- A senior student of the College is selected as Medical Prefect who coordinates with the College Authorities in case of any indisposition.
- Source share to be an all the medical expenses during illness.
- ➤ It is the responsibility of the local guardian to shift an indisposed student from the Hostel at the earliest if the circumstances demand so. Local guardian must be available in such situations.
- > However, in case of emergency the College Authorities may arrange for hospitalization, but the presence of the local guardian is mandatory.









# Prizes and Certificates

The College awards many prizes and certificates to its students on the basis of their performance both in the academic and extra-curricular activities. All prizes are awarded to the students during the Annual Function of the College.

#### Prizes:

There are two categories of prizes: i) Prizes awarded on the basis of academic performance in the University Examinations. ii) Prizes for extra-curricular activities.

Prizes on the basis of performance in University Examinations :

The College awards prizes to the students standing first from the College in the B.A. /B.Sc. Examinations, as well as to those standing second and third, provided they secure first class marks.
